In the case of Vehicle at S.No.4, which belongs to ACASH, the demand draft, however, may be drawn in favor of ACASH, New Delhi. All the quotations should be submitted in a sealed cover superscribed as “ **Quotations for old and condemned cars and three wheelers**”. The quotations should be addressed to the Addl. Development Commissioner, O/o DC (Handlooms), Room No.55-A, Udyog Bhawan, New Delhi latest by 5.00 pm of 22nd September 2009. Quotations received after stipulated date/time shall not be entertained. The quotations will be opened on the **23rd September 2009 at 3.00 PM in Room No.55-A, Udyog Bhawan, New Delhi. The tenderer, who wish to be present at the time of opening of tender, may do so by intimating the undersigned at least a day in advance. The bids with overwriting/cuttings in the quoted rates will not be considered.**

4. The vehicles will be disposed off on as is where basis is. The bidders will not be allowed to withdraw their bid(s) and in case of any withdrawal of bid(s) or in case the bidder backs out for whatever reason (s), the earnest money of the said bidder will stand forfeited. The successful tenderer will have to remove the vehicles at their own expenses immediately after acceptance of the quotation and after making the required payment. The entire money will have to be deposited within two days after acceptance of the bid by way of a Demand Draft drawn in favour of PAO, Textiles New Delhi.
