Sub:- Organization of National Handloom Expos/Special Expos during the year 2009-10

Sir/Madam,

It is proposed to organize National Handloom Expos/Special Handloom Expos during current financial year 2009-10 as per the list enclosed.

The State level Special Handloom Expos have to be participated by the **concerned State agencies only**.

The Apex Societies/ Corporations are requested to get in touch with the implementing agencies for exact dates and venue and also with the Commissioner/Director In-charge of Handlooms and Textiles regarding their participation in the above expos.

Commissioners/Directors In-charge of Handlooms of all States are requested to sponsor at least 2-3 genuine Handloom agencies for their participation directly to the implementing agencies with the instruction that:-

- i) The participating agencies will sell genuine Handloom products during the expos and if found selling fabrics other than of handloom origin or selling fabrics other than of their states, they shall be debarred for two years from participation in the future expos organized by this office.
- ii) They may also be instructed to contact the implementing agencies for their allotment of space and other information in this regard.
- iii) The participating agencies will ensure before their participation, that the goods have been insured by them .

- iv) No compensation will be given by this office in case of any goods missing or damaged during expo/transit period. Participating agencies are fully responsible for their goods.
- v) The Implementing agency will submit the number of beneficiaries & sales generated of each agency participated in the Expos.

1. The Implementing Agencies shall ensure the following:-

- b) The implementing Agency should maintain a record of goods of participating agency alongwith value of goods.
- c) Agency-wise, date-wise sale figure alongwith the profit.
- d) The stall to the participating agencies will have to be allotted through a lottery system Space-wise etc. First priority will have to be given to those agencies which have been recommended by the Commissioners/Directors In-charge of Handlooms and Textiles for their participation and allotment of space.
- e) Implementing Agencies will have to ensure that no subletting is done by the participating agencies during expo, and if any incident of subletting is detected, action shall be taken against the participating agency and also against the implementing agency in case connivance the act of subletting.
- f) The implementing agencies should allow participation of only those agencies, which undertake to sell handloom products only and also sell products of their states.
- g) The implementing agency will take an undertaking (as per format enclosed) from the participating agencies that they will sell handloom products only and also sell handloom products of their state and if found guilty, they may be debarred from participation in the future expos organized by this office for a period of two years.
- h) The Officer In-charge of concerned Weavers Service Centres will be a member of the committees constituted in connection with the above expos by the implementing agencies.
- i) The Implementing agency shall submit the number of weavers benefited agencywise.
